### NordForsk



- NordForsk is a *platform* for joint Nordic research and research infrastructure cooperation in the Nordic countries.
- It was established by the Nordic Council of Ministers in 2005.
- Vilja till Forskning? 2011
- New statutes and new composition of the Board from 2014
- The aim of the organisation is to *facilitate* cooperation in research when this *adds value* to work being conducted nationally.
- Basic funding is provided by the Nordic Council of Ministers and additional funding by stakeholders especially the Research Councils in the different countries ("The 2/3 principle").
- The Board is in the process of developing a new strategy for 2015 -



### **How NordForsk works**



### **Principles:**

- Responding to stakeholder opinions and interests
- Common pot for high quality
- Critical mass for future Nordic strength
- Co-funding from at least 3 Nordic countries (larger initiatives)
- Nordic research cooperation should be promoted in an international context



- Increasing the visibility and impact of Nordic cooperation on the science and society arenas within the Nordic region and globally



### **Nordic Register Research**

- NORIA-net report
- Infrastructure pilots (Action plan 2014)
- From the Research Infrastructure Conference, November 2013:

1) Simplify Nordic research support operations carried out by the Nordic Bureaus of Statistics, national health registry institutes and other register hosting bodies.

2) Set up procedures of mutual recognition for ethical review permissions between the Nordic countries.

3) Support approximation of Nordic legislation and practices for using personal data in cross-border research.

4) Support the development of technical solutions enabling secure transfer, storage and access to research data across borders, possibly through the Nordic e-Infrastructure Collaboration (NeIC).

5) Investigate possibilities to create a unified data sharing facility in each country for example such as the Danish solution on health data.

6) Launch funding schemes for research pilots and training programs aimed at using joint Nordic data sources.

7) Set up a Nordic Initiative to support, monitor and develop register-based research

### Funding



## Nordic investments generate <u>at least</u> three times the invested sum for joint Nordic research and research infrastructure

- 58% funding from national stakeholders (see table below)
- An additional 50% of a project is financed in kind by universities/research institutes (according to Damvad).
